Whereas the Town of Shoshoni recognizes a need for a permitting process to allow certain activities within the town limits, whereas the citizens of the town have expressed interest in obtaining permits to keep rabbits, chickens and other fowl within the town limits, the Town sets forth the following procedure of permit process.

A permit may be granted for the purpose of keeping of rabbits, chickens or other fowl. The permit, when granted by the Town will supersede Town ordinance prohibiting such activities. The Town Council has the right to grant, deny or revoke any such permit.

Requirements:

- 1) Person wishing to apply for permit must fill out permit application in full.
- 2) Pay non-refundable one time permit fee of \$25.00
- 3) Have no animal control ordinance convictions within the past 12 months.
- 4) Attend the Town Council meeting at which application is being considered.
- 5) Obtain a building permit for the construction of the coupe to house the chickens or fowl.
- 6) Provide Town with a plan for the disposal of waste created by keeping of such animals. No long term storage or stockpiling of waste.
- 7) Provide Town with the assurance of the keeping of such animals will not hinder neighborhood property owners within 300 feet from their rights to use and enjoy their properties.
- 8) Provide Town with the assurance that the keeping of such animals will not result in an issue of public health, safety or become a public nuisance.
- 9) Provide Town with the property owners written, notarized consent to allow such animals on the property if applicant is not the legal owner.

Limitations:

- 1) No more than 25 or a combination of chickens, ducks, or other fowl is permitted. No roosters (male) over the age of 3 months.
- 2) No more than 6 rabbits are permitted.
- 3) Chicken coupes or rabbit hutches are only allowed in the rear (back yard) of the property.

Enforcement or Revocation:

- 1) Town has right to inspect premises during reasonable hours with the presence of permit holder.
- 2) A written warning will be issued to permit holder for any permit violations giving them 5 days to rectify the issue.
- 3) Failure to rectify the issue within the allotted time frame will result in the permit holder being summoned to the next available Town Council meeting to answer to complaint and show cause why permit should not be revoked.
- 4) Town Council has right to revoke permit. Upon revocation of permit, the former permit holder has 7 days to remove such animals. Failure to remove animals will result in a violation of Town animal control ordinance for harboring or keeping of such animals.
